#### AIR CONDITIONING in SCHOOL LOBBY Kobi Benita & Howard Smith

The reception area in the front lobby of the school is VERY warm. There is always a person from the Children's Museum situated in that area as a security measure to control who is entering the building. The CM has requested that a split unit AC like what was installed in the classrooms be installed, with them paying for 40% and the Emanuel paying for 60%, as was done with all the other units in the school wing. The CM will lay out the funds so it can be installed in the very near future, and the synagogue will reimburse them with monies in the 2023-24 budget.

#### BUDGET Mickey Libbin

Budget for 2023-24 currently reflects a surplus of \$35,040, but that figure is subject to the three employment contracts (Rabbi Small, Barbara Fink, & Moshe Pinchover) yet to be finalized. The Finance Committee also had a question as to how strongly projected dues would come in. The budget also reflects a 5% increase across the board, in dues, fees, rentals, etc. The current donations line includes income from the Children's Museum and the Minyonaires for contributions to AC installation; those amounts will not be there to be included for 2023-24. The new budget includes 26 new family units, bringing in \$14,416 in billable monies. Though the number of family units is down, this reflects a "cleaning up" of the books, with removal of deceased members as well as members who had not paid in several years.
