motion (made by Jackie Isaacson/seconded by Rick Lasker) to accept consent agenda (2/24 minutes, governance committee report, adult ed report, house committee report) passes unanimously

CEMETERY COMMITTEE Tamar Margolis

The Cemetery Committee has been discussing the issue of markers and foundation. The setting cost, made by US Cemeteries, has *not* been passed on to plot owners, but has previously been absorbed by the Synagogue. The cost is different for each foundation, but the committee wants to add the setting cost in the price we send out. The process of billing is still being discussed by the committee. the cost could arise six months to a year after the funeral, and costs between \$100-\$300. The procedural document that will be issued after the Cemetery Committee concludes meetings will address the issue, but it is costing the synagogue *now*, and should be tackled now.

MOTION: (made by Tamar Margolis/seconded by Ken Simon) Recommend to BOT that Emanuel establish a policy to include the setting fee in the prices that are communicated to the monument company *motion passes unanimously*

TORAH PROJECT Tamar Margolis

Sofer Rabbi Hale was at the Emanuel March 3rd, and it was a great experience for all who participated. He will be back March 31st, as well as two dates in May. We have raised \$100,000 so far, from 149 family units. Participants got to write on a scroll that will be kept at the Emanuel as well as take home the quill that they used. The experience reminds people what kind of synagogue we are and helps elevate us.

LANDSCAPING Hilda Slivka

Hilda, Andrea Goldenberg, Jackie Isaacson, and Gail Weinstein have been involved in investigating what to do to the area outside Cantor Risman's window, where all of the dense plantings were removed for security reasons. Committee members met with three landscapers, and ultimately decided to go with the plan and selections recommended by Moscarillo's.

Though technically it is not a security issue, the old plantings were removed for security reasons only and therefore the funds should come from security. Plants chosen require little pruning, though mulching will have to be done every 3-5 years. There are also plans to put a hose in the garden area on a timer for watering.

MOTION: (made by Hilda Slivka/seconded by Jackie Isaacson) **Hire Moscarillo's** to take care of landscaping near the rear entrance of the synagogue (that is now our primary entrance) at a cost of \$7009.10 with the funding to come from the Security Fund

YES 22 NO 1 motion passes

There is currently approximately \$133,000 in the Security Fund "available" for use, though that is not the amount of actual cash in the fund. We are waiting on reimbursement from FEMA 1, and are submitting FEMA 2 for reimbursement. A State Grant of \$50,000 is being applied for. We have ERC monies sitting in a separate account, awaiting a decision of what to do with it. We have not yet taken monies from the Endowment Funds for this year.

RESTROOM RENOVATION Hilda Slivka

Committee members Hilda, Andrea Goldenberg, Pam Simon, Jackie Isaacson, Gail Weinstein, and Tom Mastronarde and Rick Lasker have had discussion with BMR Enterprises about renovating the pink women's restroom and updating the family/handicap restroom outside of Silverman Auditorium. This is the same contractor who did our last bathroom renovation. The project will also include installing cutoff valves in that area so that the entire building, including the Children's Museum, will not have their water shut off at all times when working in that area. The bid received was \$120,482. There is currently \$11,000 left in the restroom renovation fund from the last renovation. There is \$70,000 in the gift card fund, which Joanne Pasternack would like to see allocated to use for this renovation. Hilda will be reaching out to members to try and raise an additional \$10,000. We are suppose to limit how much we take from CIR resources in the course of a year. It is not recommended to take monies from the Beth Hillel Building Fund, as those funds go to pay Rabbi Lazowski. The Finance Committee will investigate further. The CIR currently has \$91,000. The Reserve Contingency Fund currently has \$19,000.

MOTION: (made by Hilda Slivka/seconded by Jackie Isaacson) **Approve bathroom** restoration project at a cost of \$120,482 with the funding to come from the bathroom renovation fund, gift card fund, reserve contingency fund (\$10,000) and CIR (\$30,000).
