Emanuel Synagogue Security Committee

Status Report – 6 Apr 2022

Background

The security committee was tasked to review a security assessment report, also referred to as a TVRA Report (Threats, Vulnerabilities, Risk Assessment) issued by SCN (Secure Community Network). The assessment was conducted on Oct. 19, 2021, by John Colangelo (Community Security Director for Jewish Greater Hartford). The SCN report identified 59 security vulnerabilities, which have been consolidated into twenty (26) issues, many of which are common issues that exist in multiple areas (example: inadequate security camera coverage, inadequate exterior lighting, etc).

Status of Review

The security committee has:

- completed a review of the identified vulnerabilities
- reached consensus on the disposition of all vulnerability issues
- reviewed and endorsed all mitigations already put in place by the 2019 Security Committee (such as identification of safe spaces, upgraded door locks, etc).

Record Security Committee Meeting - March 31, 2022

The security committee reached consensus on disposition of all vulnerability issues raised in the SCN assessment. That also reached consensus on recommended actions to mitigate risks identified, including those mitigation projects that are eligible to be included in an application for a FEMA grant in the 2022 NPSG program. Please note that FEMA has not yet issued the notice of opportunity to submit an application, stated the limit for the maximum grant amount, or specified rules for what types of projects will be eligible for the 2022 grant program.

All six (6) of the security upgrade projects recommended by the security committee for implementation are listed in the table below.

Upcoming Security Committee Meetings

No further meetings of the entire committee are scheduled at this time. A number of committee members, however, are engaged in preparing bid requests to suppliers, cost estimates, and descriptive details to support the development of the Emanuel application for the 2022 FEMA grant program.
